Presentation formats

Workshops - *In-person*

Presenters lead a 30-minute workshop to demonstrate a technique or methodology in an engaging, interactive format. Workshops are designed to foster the development of new knowledge and skills through hands-on, collaborative participation. Both students and faculty are welcome to lead workshops.

Posters - *In-person*

Posters are displayed together in a large room for 1.5 hours, during which authors present their work individually to attendees who wish to discuss it. Presenters are responsible for printing their own posters.

Research presentations (12-15 minutes) - *In-person*

This format is ideal for students looking to gain experience presenting their research to a public audience. Presentations should be 10-15 minutes, with 2-4 talks grouped per session. Session moderators will keep time, and presenters are expected to stay for the Q&A at the end.

Two types of submission

Submitting your proposal depends on the presentation format.

TYPE 1

Each of these presentation formats :

- Research presentations (12-15 minutes)
- Posters

Must follow the following structure:

1. Objectives and/or research questions
2. Conceptual/theoretical framework or model
3. Methodology/procedure
4. Findings or conclusions

TYPE 2

This presentation format :

- Workshops

Must follow the following structure:

1. Session theme and objectives
2. Session outline
3. Value for graduate students/researchers

For all submissions, this main information should be mentioned: corresponding author, e-mail address, first name, last name, institutional affiliation, submission title, language of communication, submission type, co-author(s), keywords (maximum 5), abstract and references (APA 7th edition).

Submit your proposal for research presentations

To submit your proposal you must complete the following information:

1. **Submission title**

4. **Alternate submission type** (optional) : choose another submission type for which you would be willing to present

To submit your proposal you must complete the following information:

5. **Submission strand** : Symposium Jean-Paul Dionne 2026
6. **Authors** : Precise first name, last name, pronouns, email. If the submission has only a single author, you can leave this field blank and your current information will be used

Prepare your proposal before submission

It's a good idea to prepare your proposal for submission, whatever the format.

For example, to submit the proposal for presentations and posters, this means that the abstract should be written as follows:

- Three or four sentences to contextualize the problem.
 - How important is research?
 - Why is your research and argument important?
 - What practical, scientific, theoretical or artistic gap does your project fill?
 - Why would a reader be interested?
- Two or three sentences to summarize the key theories/approaches you'll be drawing on.
 - What theories does your work draw on or include?
 - What important concepts does your work take into account?
- Three to four sentences to introduce your methodology and objectives AND/OR the subject of your discussion
 - What did you do to obtain your results? (e.g. analysis of 3 novels, cursory literature search, interview with 17 students)
- Five or six sentences to present your findings or conclusions
 - What did you learn, invent or create by following the above procedure?
 - What are the wider implications of your findings, particularly for the problem or gap identified above?
 - Why is this research useful?

Writing examples for posters and presentations

Objectives and/or research questions :

Despite the growing number of studies conducted in intercultural environments, researchers tend to omit the translation process in their methodology.

Conceptual/theoretical framework or model :

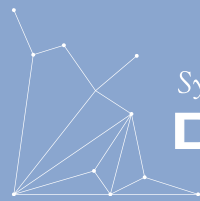
However, literature shows that translation may greatly affect the validity of a study. Indeed, from a socio-constructivist point of view, all interpretations are subjective. Because a translation is the translator's interpretation of the meaning in the source language, the translator undoubtedly influences the outcome of the analysis conducted on the verbatim translation. For this reason, we believe that the translation process and some information on the translator's qualifications should be mentioned in the methodology. (rationale)

Methodology/procedure :

In this presentation, we start by giving an overview of the history of translation in Canada, followed by a description of practical and epistemological implications of translating qualitative data. We then address the translator's competence and common sources of mistakes. Finally, we present and examine three translations from Spanish into French of qualitative data on language representations made by three translators with completely different profiles. We describe the main differences and explain how they might have been affected by the translators' background and how they might influence the results of the study.

Findings or conclusions :

The results show that the translators' language variation and training, among others, might influence the translation quality, and consequently, its validity.
